What is corporate finance with an example? An example of corporate finance is a company issuing bonds to raise funds for expansion, thereby leveraging debt financing to support its growth initiatives.

senior management with a forecast of the company's profit and loss (income statement) and operating performance for the upcoming quarter and year.
