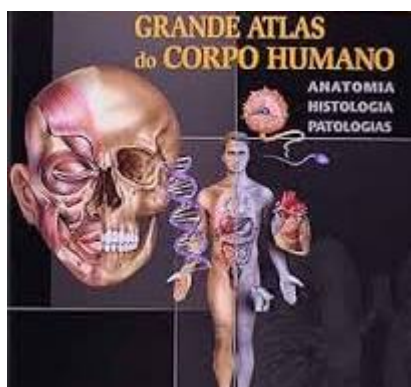


Figure Grande atlas do corpo humano: Anatomia, Histologia E ...

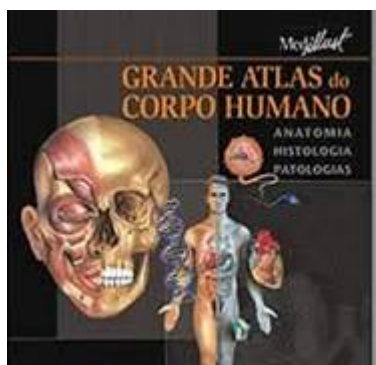

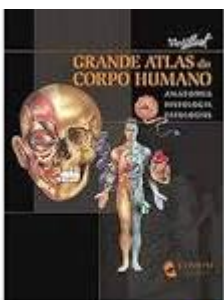

**Atlas de Histologia em cores da PUCRS**, A palavra histologia é usada como sinônimo de anatomia microscópica, devido ao seu contexto englobar não somente a estrutura microscópica dos tecidos, mas também de órgãos e sistemas do organismo.
